We demand that abortion

WHAT'S UP?

NI abortion seekers now receive funded care in UK.

There is financial help for flights & accommodation if they earn <£16K/on benefits

Travel is often not an option; Intimate Partner Violence, caring duties, zero-hour contracts, ill-health / disabilities, This forces many to buy illegal abortion pills online & risk imprisonment.

In Jan 2019 the Republic of Ireland began abortion care for <12 wks pregnant. However, a 3-day wait & >€450 makes it still prohibitive for NI folk.
